**ON-FIELD AGREEMENT AND RELEASE**

I knowingly and voluntarily on behalf of myself and/or as the guardian or parent of the guest or participant on their behalf as well as any descendants, ancestors, families, representatives, heirs, executors, administrators, grantees, assigns, and successors-in-interest and each of them, hereby completely release and forever release and discharge the Rams, the National Football League, the Edward Jones Dome and any parent, subsidiary, division, related or affiliated entity, past and present and their directors, officers, shareholders, employees, agents, representatives, insurers, attorneys, assigns, predecessors and successors in interest, past and present and each of them (hereinafter collectively referred to as the “Released Parties”) of and from any and all claims, rights, agreements, contracts, covenants, promises, demands, actions, causes of action, suits, liens, judgments, loss of services, proceedings, orders, debts, dues, sums of money obligations, liabilities, wages, accounts, damages, costs, attorney’s fees or any other fees, and or any expenses whatsoever of whatever kind or nature, in law, equity or otherwise, whether known or unknown, suspected or unsuspected, that accrued, or are based on, related to, resulting from, or arising out of my or the aforementioned minor’s participation in Promotion and all activities related thereto.

By myself or the minor’s presence on the field or participation in the promotion, I expressly represent that I have (i) read this release and understand that this is a release of all liability for guests’ or participants’ participation in the Event, (ii) satisfied all rules, regulations, and qualifications related to being on the field, and (iii) adequate medical and liability insurance, and agree that the Sponsor may rely on such representations.

I hereby grant the Sponsor on behalf of myself and as the guardian or parent of the guest or participant and their successors and assigns, the unrestricted right to use my or the minor guest/participant’s name, likeness, or appearance on any cards, posters, calendars, photographs, video material, film material, electronic material, or other similar promotional material in any form, content or medium in order to promote or market any or all of the Sponsor.

I hereby expressly release and waive any demand, action, claim, license, royalty, or other form of payment I and/or my agents, representatives or assigns, may have based on claims to rights of privacy, publicity, notoriety or any other rights arising out of or related to any use by the Sponsors of my name, likeness, or appearance or that of the minor’s.

My signature indicates I am fully aware of the consequences should I attempt in any way to break the above restrictions.
